FORMULATION ADVICES: Laboratory scale - 2 kg - Silverson

Weight ingredients of phases A and C. Use hot water (75°C). Disperse polymers of phase B on the surface of phase A+C. Homogenize with a rotor/stator turbine during 2 minutes at 3000 rpm. Add phase D with a spatula. Adjust pH.
