STABILITY: 1M at RT, 45°C.

FORMULATION ADVICES: Pilot - 2 kg

Melt ingredients of phase at 85°C under agitation at 300 RPM. Cool down at room temperature until 50°C. Add phase B mix well at 1100 RPM. Cool down until 40°C and fill the packaging.
